Conduct of Delegations:

When addressing members at a council meeting, a delegation shall adhere to the following guidelines:

- (a) Avoid speaking disrespectfully of the federal government, the provincial government, or another municipal council, or any official representing them.
- (b) Refrain from using offensive words in referring to a member, an employee of the municipality, or a member of the public.
- (c) Avoid reflecting on a vote of council except when moving to rescind or reconsider it.
- (d) Refrain from reflecting on the motives of the members who voted on the motion or the mover of the motion.
- (e) Avoid shouting or using an immoderate tone, profane, vulgar, or offensive language.

Improper Conduct:

- 37.1 The reeve may request that any person in the public gallery who disturbs the proceedings of council or acts improperly at a council meeting, as set out in section 39 (Bylaw 03-2022), leave, or be expelled from the meeting.
- 37.2 The reeve may request that any delegation who addresses council improperly as set out in section 40 (Bylaw 03-2022) leave or be expelled from the meeting.
- 37.3 No person shall refuse to leave a council meeting when requested to do so by the reeve.
- 37.4 Any person who refuses to leave when requested to do so may be removed.
- 37.5 If a person disturbs the proceedings of council or refuses to leave when requested to do so, the reeve may recess the meeting until the person leaves or adjourn the meeting to another day.
