 - (11) One additional single detached dwelling, manufactured dwelling, or mobile home as an accessory use to a farm operation, intensive livestock operation or intensive agricultural operation on the remainder of the quarter section from which the AR parcel has been subdivided.
- 2. Section 12.6 Standards for Discretionary Uses is amended by adding the following subsection:

- 12.6.6 Dwelling units as accessory use to an agricultural operation on the remainder of the quarter section, which is operated by owners of the AR yard site, subject to Section 4.14.10 of this Bylaw and Section 3.4.2(5) of the Official Community Plan.
- 3. Dwelling accessory to agricultural operation is added to Table 12-1 having the same development standards as single detached dwellings.
