## SPECIAL EVENT/PARKING PERMIT INFORMATION & APPLICATION

The undersigned hereby submits a formal request to the Municipal Administrator (or designate) of the Rural Municipality of Vanscoy, seeking consideration for an exemption from certain provisions outlined in Bylaw 12-2023, known as The Noise Bylaw, and Bylaw 08-2022, known as The Traffic Bylaw.

- The purpose of Special Event/Parking Permit:
  - Designate specific Highways within the Rural Municipality of Vanscoy No. 345 as parking zones or limited parking zones during a special event.
  - To grant permits for participants of special events.
  - Set terms and conditions for granting permits.
- Parking Compliance:
  - The vehicle must be parked in accordance with all other provisions of Traffic Bylaw No. 08-2022.
- Eligibility:
  - Any owner of the property may apply to the Rural Municipality of Vanscoy No. 345 for a special events parking permit.
- Permit Issuance:
  - If the application complies with the outlined terms, a special event/parking permit shall be issued.
- Application Timeline:
  - Application for the permit must be made at least fifteen (15) days prior to the event.
- Traffic Warning:
  - The special event owner shall erect all appropriate signage to warn traffic of the upcoming event.
- No Application Fee:
  - No application fee applies.
